Bioregionalism: Try it, you might like it. And it may just save the world.

Bioregionalism is a philosophy that suggests that political, cultural, and economic systems are more sustainable and just if they are organized around naturally-defined areas called bioregions.

Bioregions are geographical areas defined by distinct ecological systems, plant and animal species, soils and landforms, human settlements and cultures, and topographic features such as watersheds. Bioregions can of course spill across political boundaries.

If you think about it, human societies were arranged around bioregions for most of human history, it is in the relatively recent history of humanity that we started dividing into states, and even then, many of our borders respect bioregion lines of rivers, mountains, oceans, and lakes.

Bioregionalism is a growing movement to again organize in bioregions in order to protect them and regenerate them, thereby protecting ourselves and addressing the issues of climate change and overshoot that are coming

The appeal of bioregionalism – at least to me – is that it focuses on the familiar and the local and is there-

fore more likely to spur action than a global problem that is abstract to most people, such as climate change, deforestation, biodiversity loss, or any other planetary boundaries. If more people knew about and cared for their bioregions, those that spoil our rivers, lakes, mountains, and oceans would have a harder time doing so.

Throughout human history we had to take care of these resources, because they took care of us. Now, most of us live in cities and suburbs where we have separated ourselves from nature, so we don't feel the need to take care of it.

Most of us go into nature every once in a while, but we don't feel ownership of it, so we don't protect it.

How do I get involved?

The first step is to know where the hell you are. The good folks at One

Earth have a great Navigator that helps you find your bioregion. Give it a test-drive: Navigator | One Earth at https://www.oneearth.org/navigator/

There are 185 bioregions around the Earth. I found out that I live in – the Appalachia & Allegheny Interior Forests (NA24) bioregion.

You can take it a step further and learn what watershed you live in. The entire world is made up of [watersheds]. A watershed is a drainage basin. Your watershed could be pretty small, making it easier to get involved in cleaning up and regenerating. I could only find watershed information in the U.S., but here is an easy tool. Find Watersheds at http://www.fishmap.org/watershed.html.

I'm in the Rivanna watershed.

One you know your bioregion and your watershed, you can look up local groups looking to protect your bioregion and watershed or start one yourself.

If you are looking for a place to learn more about bioregioning and find people and events, go to r.3.0 [r3.0 | Redesign for Resilience & Regeneration for a green, inclusive and open

Here's what they say they do in their own words:

r3.0 promotes Redesign for Resilience and Regeneration. As a global common good not-for-profit platform, r3.0 crowdsources open recommendations for necessary transformations across diverse fields and sectors, in response to the ecological and social collapses humanity is experiencing, in order to achieve a thriving, regenerative, and distributive economy and society.

Go where the money is.

They want to help create bioregioning banks, funds, venture capital, and other resources to help bioregionalism thrive. Yes, the people at BioFi are already BFFs with the r3.0 people.

If you want to find out more, you

can read the book *Bioregional Financing Facilities* by Samantha Power and Leaon Seefeld. The link is on the BioFi project link.

It's a great gift for that person in finance or business who wants to save the world, but doesn't know how to do it.

Here's the plan.

Start local. Get involved in protecting your bioregion and your watershed, and invite friends, family, and mortal enemies to do the same. Once enough of us know the link between our bioregions and our survival, it gets harder to ignore the problems in our bioregions and assume someone else will take care of them.

A good analogy is renting vs. owning. If you own something, you take better care of it. If you just rent it, you don't. How well did you look after that first apartment you rented? How well do you take care of the home you own now (if you own a home ... essay for



They aren't.


If enough people own their bioregion, they will fight like hell to protect it.

Victory: Wind Project Threatening Endangered Whales Stopped

Dear Supporters,

I am glad to announce that the Atlantic Shores South wind project off of Long Beach Island (LBI) and Brigantine, New Jersey has been sunk. Shell New Energies, a 50 percent owner, is stepping away from it — notably 20 days after Save LBI filed a comprehensive federal lawsuit against the project. The New Jersey Board of Public Utilities (BPU) has decided not to make a new enabling subsidy award to it. The existing BPU award that it had for project 1 will be terminated without penalty.

Our sincere thanks to all of you who have made this possible.

Save LBI is gratified that the Atlantic Shores South project has been tabled. This is a major victory for shore values, communities, others, and common sense. But there is also unfinished business here to ensure that this project, or a similar one, never reappears, and that the flawed federal and state processes and impact assessment methods that carried such a costly and damaging project this far are fundamentally changed.

There are a number of ways to do that.

1. Federal Legislation. The removal of the investment tax credits

and other incentives in the Inflation Reduction Act would ensure that these companies will not make sufficient return on their investment here.

2. Cancelling the Lease Area. An effective way to permanently end this project – and prevent future projects in the same area – is to cancel the lease area itself. Only the Interior Department can do that. We have written to Secretary Burgum suggesting that and will be filing a formal petition asking for cancellation. Our recent federal lawsuit provides ample justification for such a cancellation, but we do not yet know whether the Interior Department will do that or how long it will take.

3. Overturning Prior Project **Approvals.** The prior Atlantic Shores project approvals can be overturned. Atlantic Shores or any new project would then have to start over with a new environmental impact statement, and other applications. This requires a Court judgement so we must continue our lawsuits. It is possible now that Justice Department lawyers may agree with some or all of our claims. A Court judgement that the Atlantic Shores approvals were not lawful and overturning them would set a precedent for other cases because the methods used elsewhere were similar.

4. Protecting the North Atlantic Right Whale. A safe migration corridor along the East Coast is essential for the critically endangered North Atlantic Right Whale. We will soon be filing a petition with NOAA (the National Oceanographic and Atmospheric Administration) to designate a migration corridor for the Right Whale as critical habitat. That petition will demonstrate that offshore wind projects in that corridor would seriously impede or block the whales migration. So, we will ask that all wind projects

be excluded from that critical habitat corridor. The Atlantic Shores lease area is entirely within the migration corridor we will propose.

5. Doing Things Right. The Administration is conducting a welcome review of the leasing and permitting practices for these projects. We too should reflect on how a project with virtually no benefit, high cost, and significant environmental damage got so far. Our work on this over the last few years showed that the entire process of site selection and project review was fundamentally flawed. The public was excluded from the selection of the lease area, the most important decision. Alternatives to the company's proposal were excluded from the environmental impact statement rendering it essentially worthless in terms of fostering wise environmental decisions. Opposition groups were excluded from the preparation of documents prepared under the Endangered Species Act and the Marine Mammal Protection Act. Noise-related impacts to marine mammals have been systematically and significantly underestimated, and changing those methods is

paramount to protecting these animals for any offshore project.

Save LBI will do what it can to correct these defects. We will continue and expand our efforts to inform the public, the media, and our elected representatives as to the true costs and impacts of these projects on the leasing, environmental review, and financing practices used and how they should be changed, and provide constructive energy supply options to keep the lights on.

Join us on February 16th, World Whale Day. We will be marking our progress and committing to the work ahead on the Seaside Park boardwalk at the Funtown Beach Pavilion (Stockton Avenue) at 1 PM on February 16th. We welcome your presence there, your continuing support, and any suggestions.

These 28 NJ Animals Are Now Considered Endangered

State wildlife officials have reclassified 28 species of animals found in the state as endangered or threatened, including five species of freshwater mussels, six dragonflies, two butterflies, three amphibians, two reptiles, wand 10 birds.

NEW JERSEY – State wildlife officials have reclassified 28 species of animals found in the state as endangered or threatened, part of a series of amendments recently adopted into the New Jersey Administrative Code.

The new additions to New Jersey's list of endangered animals include five species of freshwater mussels, six dragonflies, two butterflies, three amphibians, two reptiles, and 10 birds.

Animals on the list include the barred owl, wood turtle, Pine Barrens tree frog, and northern pine snake.

Before the change, which went into effect on January 6, the animals moved to the endangered list were considered "threatened" but were kept on the state's non-game list. An animal on the non-game list is placed into three categories, including "special concern," "stable-secure," or "undetermined-unknown."

As part of the change, animals on the endangered list are now considered "threatened" or "endangered," a classification that includes the most at-risk species.

The changes included the removal of four animals from the endangered list, including the bald eagle and the osprey. The animals were moved to a list of regulated non-game species after their populations increased.

The Trump Crime Spree

This is a particularly hard moment to live through, but it is not the last word on what will happen.

Elect a criminal and get someone who commits crimes. Elect an insurrectionist criminal and get someone who commits crimes against the government he pledged to serve.

That's where we are in the third week of the Trump sequel, during what we knew would be a chaotic and overwhelming start to the administration.

At its core, what Trump is doing should not be surprising. We knew we would have to brace for an unprecedented flurry of attacks on the political process. But that doesn't make it easier to experience. Something can be predictable and shocking at the same time.

Because you follow the news, you don't need me to recount all the things Trump is doing in his effort to grab power, so I will focus on two of his most egregious and unprecedented actions. He has permitted Elon Musk access to Treasury Department computers — essentially the nation's checkbook — which gives Musk proximity to the sensitive personal information of hundreds of millions of Americans.

Meanwhile, Musk has moved to shutter the U.S. Agency for International Development (USAID), while Trump ordered a freeze on international foreign assistance. An act of Congress is required for the former, while the president does not have the authority to do the latter.

None of this is constitutional and none of it is legal.

But Trump, as expected, is doing it



anyway, daring anyone to make him stop.

In a functioning democracy, impeachment hearings would already be underway, and they would have bipartisan support. But in the degraded democracy Trump inherited, there was never any chance of this happening. We knew congressional Republicans would not provide a guardrail against his actions, and we are seeing this play out.

We also knew coming into the new administration that the courts and federalism would likely be the only remaining institutional obstacles to Trump's lawlessness. And we are seeing this happen as well, although it may not feel like it is effective because legal action takes time while Trump and Musk are destroying things at a dizzying pace.

Three federal workers' unions have sued to block Musk's access to the Treasury database. The dismantling of USAID will inevitably face court challenges. A federal judge has blocked all vestiges of a spending freeze Trump ordered then reversed course last week. On the political front, House

and Senate Democrats rallied in front of USAID offices yesterday to draw attention to the extra-legal efforts of the Trump administration. Said Rep. Jamie Raskin, "We don't have a fourth branch of government called Elon Musk, and that's going to become real clear."

Given the imbalance between the swift execution of illegal executive authority and the slower judicial response, it should not be surprising that Trump holds the offensive initiative right now. And real damage is being done as a consequence. But we also need to give the forces pushing back time to get established.

It can also be helpful to remember that Trump will fold when challenged. Just look at how quickly he gave in on his tariff threats against Canada and Mexico when the market and some investors registered their concerns. Or, as the *Wall Street Journal* put it, Trump blinked.

It is also the case that the unhinged start to the second Trump presidency isn't helping his public standing. And he didn't have much standing to begin with.

Like the courts, public opinion can move at less than lightening speed. It takes time for people to notice what's happening and form an opinion. Sometimes their personal situation has to get really bad before they do. But Most Americans already have an unfavorable view of Musk and his DOGE project. It's unlikely to comfort them when they learn that he's rummaging around in their personal data.

* * *

If the person who swore to uphold the law wasn't the one violating it, we would have avenues for swift action that could halt this crime wave in its tracks. Instead, we are forced to rely on the slower mechanisms that remain available to us. It can be hard to feel good about this when so much damage is being done, although it is also the case that the destruction we're seeing was baked into the results of the election. We knew this – and more – would happen back in November. We're just living through it now.

How things develop will depend on how effectively the opposition can come together and leverage legal and political tools to push back on the bully. Trump is determined to upend the global order and our national stability, but there are plenty of people invested in the status quo who will not stand by and let him have his way without a fight.

Trump has an enormous advantage right now in the executive power he wields, and in his willingness to abuse his office knowing his party will not stop him. But we are not without tools.

This is an exceedingly challenging moment, and it can feel like all is lost, but the opposition is not helpless.

Ocasio-Cortez says Trump Admin Trying to 'Overwhelm' with 'Constant' Developments

Submitted by Bill Boteler, Maryland USA with this comment: "Advice on overwhelm. This is essential advice about how Trump is using psychological tactics to demoralize us. That a national leader would do this is unprecedented."

Rep. Alexandria Ocasio-Cortez (D-N.Y.) said the Trump administration is aiming to "overwhelm" the public with "constant" developments in a Tuesday livestream on Instagram.

"I want you all to understand that if you are watching the news right now, and you are feeling overwhelmed by all of the constant headlines and developments and what is happening," Ocasio-Cortez said. "First of all, know that you are not alone. And second of all, know that that is exactly what this administration is trying to get you to feel."

President Trump has a signed a flood of executive orders that focus on stripping birthright citizenship, deportations, and wiping out diversity, equity, and inclusion (DEI) efforts, among others.

Ocasio-Cortez compared Trump's actions to that of a budding authoritative regime.

"What authoritarian regimes try to do is that they often try to, what is known as 'flood the zone,'" she told her followers, noting the goal is to do "so much at once ... that you feel overwhelmed and paralyzed."

The New York lawmaker accused Republicans of trying to usher in a "state of passivity."

Instead of being bogged down by new developments and rapid changes, Ocasio-Cortez urged viewers to rise up against the nation's leaders.

"We need to try. I don't want to hear, 'Oh, we can't do that. That's impossible.' That's called consenting in advance," she stated.

"So, when your mind says, 'It's all over, we might as well' – no, no, no.... Do not be discouraged by temporary defeats. We keep going anyway. When we are relentless, they will fatigue. They can only hold this up for so long."

Ocasio-Cortez has been vocally critical of Trump and his aim to restructure the federal government and corresponding agencies following his inauguration, targeting top officials including Elon Musk and others, in social media posts.

'A Disgrace': Trump Admin Targets Multiple Environmental Justice Offices

"Donald Trump has decided that we do not deserve clean air or water, and our right to a livable and safe planet comes second to further enriching his fossil fuel friends and donors," said one environmentalist.

The Trump administration plans to place over 100 workers who are employed with the Environmental Protection Agency's Office of Environmental Justice and External Civil Rights on administrative leave, according to Wednesday reporting from *The Wall Street Journal*, which cited unnamed sources.

Other outlets have since reported on the development, including *The Washington Post*, which wrote Thursday that Trump appointees at the EPA told staff that they plan to close the office.

This move targeting the EPA, one of the latest efforts by the Trump administration to drastically reshape federal agencies, was panned by multiple environmental organizations, who accused the White House of turning its back on vulnerable communities.

"The EPA's environmental justice office was created to challenge the historic pattern of pollution disproportionately affecting low-income communities and communities of color," said Chitra Kumar, managing director of the Climate and Energy Program

at the Union of Concerned Scientists. Kumar was also formerly an official with the EPA Office of Environmental Justice and External Civil Rights. Once again, the Trump administration is sidelining both science and the nation's most overburdened people."

Meanwhile, the Trump administration is also reportedly working to "remake" the Justice Department's Environment and Natural Resources Division, which defends the U.S. government's environmental actions in court and brings cases against individuals who violate federal environmental law. *The Washington Post* reported that Trump appointees at the Department of Justice said they plan to fire roughly 20 workers at the division, "among other actions that have sent morale there plummeting."

The Office of Environmental Justice within the division has already "been eliminated," and the five people working in that office have already been put on administrative leave, according to the outlet.

And in one of her first acts as U.S. Attorney General, Pam Bondi undid a Biden-era directive ordering the Department of Justice to emphasize enforcement of environmental laws in disadvantaged and low-income communities.

Trump administration attacks on what the White House deems "diversity, equity, inclusion, and accessibility" (DEIA) initiatives were expected. On his first day in office, U.S. President Donald Trump signed an executive

order mandating the end of all federal DEI programs, goals, mandates, and plans. The order also specifically called for the termination, "to the maximum extent allowed by law, all DEI, DEIA, and 'environmental justice' offices and positions."

"By shuttering these offices, Donald Trump has decided that we do not deserve clean air or water, and our right to a livable and safe planet comes second to further enriching his fossil fuel friends and donors," said Sierra Club executive director Ben Jealous in a Thursday statement. "Trump has been on the job for less than a month, but every single day he is making our communities less safe."

Like Kumar at the Union of Concerned Scientists, senior VP of environmental health at the Natural Resources Defense Council Matthew Tejada (also an alum of the EPA's environmental justice office) said that the country's most vulnerable communities would lose out.

"Shuttering the environmental justice office [at the EPA] will mean more toxic contaminants, dangerous air, and unsafe water in communities across the nation that have been most harmed by pollution in the past," said Tejada. "Trump EPA is turning its back on those who need a cleaner environment more than anyone. This is a disgrace."

'No One Is Above the Law': Judge Blocks Musk Wrecking Crew from Treasury Payment System

A federal judge early Saturday morning blocked Elon Musk's highly controversial Department of Government Efficiency, or DOGE, from further access to a sensitive and closely guarded Treasury Department payment system, warning of "irreparable harm" presented by the threat to the personal and financial data of millions of Americans.

In an emergency order that followed from a lawsuit filed by 19 state attorneys general on Friday, U.S. District Judge Paul A. Engelmayer said the Treasury Dept., in addition to suspending Musk and his team from access,

must "immediately destroy any and all copies of material downloaded from the Treasury Department's records and systems, if any."

In the coalition's lawsuit, led by New York Attorney General Letitia James, the states argued that allowing DOGE personnel – who have been characterized as far-right libertar-

ian "goons" and a "demolition crew" intent on gutting federal agencies from the inside out – access to the Treasury system was unlawful in the first place and could give them the ability "to block federal funds to states and programs providing health care, childcare, and other critical services" – none of which they are authorized to do.

Judge Engelmayer, in his decision, said the named defendants in the suit – President Donald Trump, his Treasury Secretary Scott Bessent, and the Treasury Department – will be compelled to show cause at a hearing on February 14 before a separate judge presiding over an existing challenge to DOGE's access to the system.

In a statement following the ruling, James said, "This morning, we won a court order blocking Elon Musk, the world's richest man, from accessing Americans' private data. Musk and his DOGE employees must destroy all records they've obtained. I've said it before, and I'll say it again: no one is above the law."

Under the order, as *The Washington Post* reports, "The Trump administration is prohibited from giving access to political appointees, special government employees, or government employees that are not assigned to the Treasury Department."

On Friday, *Wired* reported that an internal agency at Treasury had assessed the DOGE personnel place inside the department as "an insider threat."

"There is ongoing litigation, congressional legislation, and widespread protests relating to DOGE's access to Treasury and the Bureau of the Fiscal Service," reads a section of an email from the internal agency reviewed by the news outlet.

"If DOGE members have any access to payment systems," the email continued, "we recommend suspending that access immediately and conducting a comprehensive review of all actions they may have taken on these systems."

16 Ways Trump Has Been Defeated, Blocked, or Forced to Back Down Since He Won the November Elections

In these early days of the second Trump administration, many folks, especially Democrats, are expressing astonishment and exasperation that Trump is seemingly getting away with everything and doing whatever he wants without any checks on his power.

As a followup to my Thursday article, "All the Lawsuits Against the Trump Administration, Listed," allow me to present to you a list of 16 ways that Trump has been slowed, blocked,

or forced to back down since November 5, 2024:

1. Matt Gaetz withdraws. In November 2024, Donald Trump's first choice for Attorney General, former Rep. Matt Gaetz, withdrew from consideration after it quickly became clear he could not be confirmed by the Senate.

2. House Democrats and Republicans joined together to vote down Trump's attempt to raise the debt ceiling. In December 2024, over three dozen Republicans and nearly all House Democrats joined together to resoundingly defeat Donald Trump's attempt to raise the debt ceiling. Democratic votes will eventually be needed to raise the debt ceiling later this year, since dozens of Republicans will once again oppose it. Expect more concessions from Trump at that time.

3. Trump's threat to adjourn Congress dismissed. Also in November of

2024, Trump had threatened to adjourn Congress indefinitely and install whoever he wanted in whatever position in government he wanted. Congress quickly rejected this idea.

4. Birthright Citizenship executive order blocked. Trump's attempt to block birthright citizenship for the children of undocumented immigrants has been blocked, in very harsh language, by multiple judges, including an appointee of Ronald Reagan.

5. Funding freezes blocked. Multiple judges have also blocked Trump's funding freezes, once again with very harsh language.

6. DOGE access to Treasury system blocked. In consultation with a federal judge, the Department of Justice has limited the so-called Department of Government Efficiency's access to the Treasury payment system to a single employee, Tom Krause. Further, this

employee has read-only access to data.

- **7.** Buyout offer for federal employees blocked. A federal judge has blocked the infamous Donald Trump/ Elon Musk buyout plan to all federal employees.
- **8.** Trump backed down from tariffs on Canada and Mexico. Trump reversed his threats to hit Canada and Mexico with tariffs after minimal to no concessions from the two nations.
- 9. The White House backed away from some parts of Trump's "plan" for Gaza. The White House quickly walked back several elements of Trump's "plan" to turn post-war Gaza into a resort community.
- **10.** Trump's legislative agenda hasn't gone anywhere. Two days ago, *Politico* described Speaker Mike Johnson's plans to pass Trump's agenda as being "at risk of collapse."
- 11. Government funding talks are going nowhere. With a March 14 deadline to fund the government approaching, Trump's many unilateral, illegal freezes of funding approved by Congress have resulted in the collapse of talks to fund the government. A government shutdown this early in Trump's term is going to look really bad for him, but Democrats aren't negotiating until Trump stops impounding money. And, yes, Democratic votes are needed in both the House and the Senate to pass a government funding bill, even now.

- **12.** Concessions from Pete Hegseth. I admit that this is pretty small potatoes, but Sen. Joni Ernst did win some small concessions from Pete Hegseth before voting to confirm him.
- **13.** Concessions from RFK Jr. In what looks like more than small potatoes, Sen. Bill Cassidy appears to have won significant concessions from RFK Jr. in exchange for voting his nomination out of committee earlier this week.
- **14.** Legal aid to migrants restored. In a complete reversal, the Department of Justice has resumed allowing legal aid to be provided to immigrants in federal detention centers and immigration courts.
- **15.** Transfer of transgender inmates blocked. A federal judge has temporarily blocked the Trump administration from transferring three transgender inmates to a men's prison.
- **16.** Special election disaster for GOP. On January 28, in a special election for an Iowa sate Senate seat, the Democratic candidate a former public school principal won by 4 points in a district that Trump won by 21 points, flipping a red seat blue. Notably, Democrats have outperformed Kamala Harris's November 2024 vote share in every special election held so far in 2025.

This is only a partial list, as of 1:45 PM ET on Friday, February 7. By the

time you read this article on Saturday, I would not be surprised if there have been more ways that Trump has been stopped, delayed, or been forced to back down. If so, please add what happened in the comments in link below.

While it can be tempting to just throw your hands up in the air and say things like, "Trump is getting away with everything," or "No one is doing anything to stop him," a more attentive, more determined, and calmer response shows that Trump actually has been meeting quite a lot of resistance, and occasional defeat, over these past three months.

I urge you not to engage in fatalism, to look closer, to remain calm, remember that this Trumpian moment is fleeting, and to stay engaged in the fight for democracy.

Momentous Victory for Climate Justice: Rosebank, Jackdaw Oilfields Ruled Unlawful

After winning a landmark lawsuit to stop oil and gas production at two North Sea fossil fuel projects in the United Kingdom Thursday, the global climate action group Greenpeace called for applause for the campaigners who have spent years demanding no new pollution-causing developments.

"This is game-changing," said Greenpeace U.K. "And it's ONLY been possible thanks to YEARS of fighting by THOUSANDS of climate campaigners! Power to the people."

The comments came after Judge
Andrew Stewart of Scotland's Court of
Session ruled that Equinor and Shell, the
fossil fuel giants behind the Rosebank
oil and gas field and the Jackdaw gas
project, respectively, cannot move ahead
with extraction because the government
did not take into account the emissions
that would result from the projects.

The companies have poured hundreds of millions of dollars into Rosebank and Jackdaw, with Equinor saying it had lined up \$2.7 billion in contracts for the former field, with an estimated 300 million barrels of oil and gas expected to be extracted beginning in 2026 or 2027.

The Stop Rosebank coalition, made up of grassroots campaigners and organizations, said the climate pollution from Rosebank "would be more than the combined annual CO2 emissions of all 28 low-income countries in the world, including Uganda, Ethiopia, and Mozambique."

"In other words, emissions from this one U.K. field would be more than those created by the 700 million people in the world's poorest countries in a year," said the coalition. "These are among the same countries that have



contributed the least to the climate crisis but are already experiencing the worst impacts of a warming planet."

Stewart said in his ruling that, "The public interest in authorities acting lawfully and the private interest of members of the public in climate change outweigh the private interest of the developers."

The campaign group Fossil Free London promptly organized a rally outside the Norwegian embassy in the U.K. capital to celebrate the verdict and call on Norway-based Equinor not to appeal the ruling.

"There can be victories in the world of climate protest," said one organizer. "This is a big one."

The ruling was in line with a decision handed down by the U.K. Supreme Court last year, which said local authorities must consider the full environmental impact of all new fossil fuel projects before they are approved.

Thursday's ruling is the latest evidence, said Freya Aitchison, oil and gas campaigner at Friends of the Earth Scotland, that "new oil is over."

"This signals the beginning of the end for fossil fuel production in the U.K.," said Aitchison. "Political attention must immediately turn to develop-

ing an urgent and fair transition plan for workers."

"This is a momentous victory for climate justice. It shows the power of the hundreds of thousands of people who have fought against the climate-wrecking Rosebank and Jackdaw oil fields for years. The U.K. Government must now end this disastrous project, rule out all new oil fields and fossil fuel developments and focus on delivering a planned, funded transition for oil workers," added Aitchison. "This ruling is a turning point, we can and must choose a better future."

Carla Denyer, a Member of Parliament for the Green Party, called on the U.K. government, now led by the Labour Party, to "refuse consent for the 13 other oil and gas drilling projects licensed by the previous government."

Global Justice Now said the government should also turn its attention to the entire planet and support calls for a Fossil Fuel Non-Proliferation Treaty.

"This is a huge milestone towards a livable planet and away from polluting fossil fuels," said Liz Murray, head of the group's Scottish campaigns. . . .

Urgent Need to Map Deep-Sea Biodiversity

note: The rush to exploit minerals for EVs and similar technology is itself a threat to the planet. Of course, doing the science is important but there will still be a political struggle.

Note from Iona: Bill and I have been following this crucial issue for a few years. This article is dated but still relevant and I have never published it before.

In the search for battery metals, attention is now turning to the deepest parts of the world's oceans. But life in these areas is virtually unexplored and the effects of mining are therefore difficult to predict. The few inventories made so far reveal a large but unknown biodiversity – nine out of 10 species are new to science.

Ongoing electrification means that the demand for various minerals is growing at record speed. The search is now focusing on the deepest parts of the world's oceans, as the soft and dark seabed contains large deposits of cobalt, nickel, copper, and manganese. But we know almost nothing about what life is like on the really deep seabed and how it will be affected by mining.

"It is a big problem that these areas are so unexplored. We don't even know which species and ecosystems are there, so how can we describe what will happen?" says Helena Wiklund, researcher at the Department of Marine Sciences.

Companies are Lining Up

Together with researchers at the Natural History Museum in London, Helena Wiklund and fellow researcher Thomas Dahlgren have examined seafloor samples from a large, mineral-rich area in the eastern Pacific Ocean, the so-called Clarion-Clipperton zone between Mexico and Hawaii. Here, companies are currently queuing up to start mining operations. As the area is in international waters, the UN's International Seabed Authority issues mining licenses. This has not yet been done, but it is probably only a matter of time, according to Helena Wiklund.

One characteristic of the wildlife in the zone is that it is very species-rich. In shallower seas, such as the North Sea, many individuals of the same species are often found in the samples. However, in the Clarion-Clipperton samples, the researchers found many different species, but few individuals of each species.

Of 339 annelids collected, mainly polychaetes, 129 were of different species – most of them completely new to science. Previous studies indicate that more than 90 percent of the fauna in the deep sea is undescribed, says Helena Wiklund.

Species at Risk of Extinction

A further characteristic is that the species composition varies greatly from one site to another. Some species have so far only been found in a single location. If that area is mined and the whole seabed is stirred up, species may become extinct.

"This is why it is important to know how widespread different species are. If a species is only found in a limited area, it is of course more likely to become extinct", says Helena Wiklund.

In order to start mining, an environmental impact assessment is required, which assesses how species and

ecosystems will be affected. Knowing which species are present in the area is fundamental to such an assessment. And when it comes to deep seabeds in international waters, there is very little or no such information.

"There are no species lists for these deep areas, instead taxonomic literature from other areas is used, which often leads to incorrect identification. How can one then be able to predict how species and ecosystems will react? It is very important to know the true diversity, says Helena Wiklund.

Field Guides are Needed

The lack of information is due, among other things, to the fact that it is difficult and expensive to examine seabeds that are several thousand meters deep. Collecting a single sample from the seafloor can take hours, and once the animals come to the surface, they can be tattered and difficult to identify. Often you need to use DNA technology to be able to determine their species. In addition, many species are completely new to science.

"Describing new species takes a very long time. Therefore, we want to publish our results as soon as possible, so that other researchers can help. Partly by using photographs and DNA sequences from our investigations, and partly by gaining access to our collected samples that we have deposited at the Natural History Museum in London", says Helena Wiklund.

"We hope it can be a first step in producing the field guides that are so badly needed for these areas."

Global Treaty Opens Up New Opportunities

After 15 years of negotiations at the UN, a global agreement to protect marine areas in international waters was signed this spring. The agreement includes rules to limit environmental impacts and create marine protected areas.

"The agreement opens up opportunities to protect the deep sea in a way that did not exist before. But it also introduces a new layer of bureaucracy that risks hampering research if authorization processes don't work, and in the worst case scenario provides incentives for corruption," says Thomas Dahlgren, researcher at the Department of Marine Sciences.

Global Treaty to Protect the Ocean

Almost half of the Earth's surface

consists of marine areas in international waters that no country owns or controls. In March, 67 countries, including Sweden, signed the UN High Seas Treaty to protect marine biodiversity in such areas. The agreement has four parts: rules for area-based management tools including marine protected areas, environmental impact assessments, marine genetic resources, and capacity building and technology transfer.

The treaty will enter into force once 60 countries have ratified it. It then remains for individual countries to take the necessary measures in their national legislation to fully implement the agreement.

The Elders Call for Dialogue, Accountability to End Worsening Conflict in DR Congo

Note from Iona: Kabi Wycliffe was beaten to death by rebels near the border of the Democratic Republic of the Congo (DRC) last year. That prompted me to write my book on violence titled Why Was Wycliffe Beaten to Death? So Many Reasons for Violence, How Many Reasons for Love? You can see it at www.ionaconner.com.

Statement: The Elders today voice our alarm at the rapid advances made by M23 rebels and Rwandan forces in the eastern Democratic Republic of the Congo, which risk escalating into an even bloodier regional conflict.

We call for effective dialogue to extend the M23 rebels' unilateral cease-fire into a full and lasting cessation of hostilities. This must include the immediate withdrawal of all Rwandan troops, accountability for atrocity crimes against civilians, and the DRC government taking more action to protect its civilians and ensure the rule of law.

The international community has neglected this conflict for too long. It has not been vocal enough in calling for the immediate withdrawal of Rwandan troops, and an end to its long-standing support for the M23 rebel movement.

The Elders echo the call by UN Secretary-General António Guterres for the immediate withdrawal of Rwandan forces. All parties must respect the territorial integrity and sovereignty of the Democratic Republic of Congo. The DRC government bears ultimate responsibility for the security of its citizens and must make this its top priority.

We urge President Tshisekedi of the DRC and President Kagame of Rwanda to participate constructively Why Was Wycliffe Beaten to Death?

in dialogue, and prioritize saving lives. Regional initiatives such as the Nairobi and Luanda negotiation processes, sponsored by the East African Community and the African Union respectively, can only succeed with a commitment by all parties to a pathway to peace. Full engagement from African leaders is essential for any lasting progress.

This is more likely if the international community applies serious pressure – as the USA did to Rwanda in 2012,

when M23 forces first occupied Goma, leading to a temporary de-escalation. At that time, the international community also engaged in dialogue under the Addis Ababa Framework. Similar comprehensive and coordinated efforts are needed again now.

The Elders are appalled at the human cost of this conflict. We call for the protection of humanitarian and peacekeeping personnel. Over 25 million people are in need of humani-

tarian assistance and over 9 million are displaced, while women and girls continue to experience horrific levels of conflict-related sexual violence.

There must be an end to impunity for such crimes, both for the perpetrators and their political and military sponsors. We welcome the decision by the Prosecutor of the International Criminal Court in late 2024 to renew investigations in the DRC and call on all parties to support the Court's vital work.

The conflict has been fueled by the desire to control critical minerals, now increasingly needed across the world for mobile telecommunications and the green energy transition.

Businesses and consumers also have a responsibility to ensure global prosperity does not come on the back of conflict, exploitation, and human rights abuses.

Civilians in eastern DRC have paid a terrible price over the last three decades for this devastating conflict. It must be brought to an end. **Juan Manuel Santos,** former President of Colombia, Nobel Peace Laureate and Chair of The Elders



OUR FRIENDS IN ACTION Ramblings from Your Local Farmers: Corporate vs. Organic Farming

Piled under a thousand blankets and sweaters as we make some final tweaks to our crop plan, we feel the hum of anticipation to get started in the greenhouse. While we wait, we thought we'd share some of the keys to our planning for the year.

So what do we actually do here and why? How does it all work? What makes food from this farm different?

Corporate agriculture has a problem: it tries to fit the natural world and the humans that live in it into a rigid, factorystyle bottom line. The natural world, however, has been around a bit longer, been through more changes and catastrophes, and frankly knows a thing or two about how to keep things going.

Our corporate food system pumps out sub-par food, while thinking little of future food growing, growers, or eaters for that matter. In response, many of us small farms are looking at supporting the natural systems for long-term security.

For example, rather than putting tons of money into chemicals that damage soil-building microorganisms and predator organisms (while also risking human lives) to kill a pest or weed, we focus on soil health and a flourishing, balanced soil and farm biodiversity that would prevent the pest from becoming a serious problem. Does this work 100% of the time? No, but we'd rather suffer a temporary loss than guarantee that our land will be unproductive in the long term.

Everything we do is to maintain balance on the farm so that we achieve a resilient supply of food. If there is a particular weather pattern, for example, a farm only producing a single crop using only chemical methods may have a complete loss for the year. Because we grow over 50 crops and build soil to help plants buffer against weather extremes, it is unlikely that all of our crops would be affected.

How do we do this? It takes lots of planning and observation. We continue to learn the nuances of our land and match plants appropriate to the microclimates on the farm. We consciously leave areas unmanaged to create habitats. We focus on caring for the soil through soil building plants, compost, and careful tillage practices.

It is slow food and even slower money. Many of the things we do now won't make a difference for 10 years...

but we think it is worth looking a few steps ahead. In the process we build a simple life, but one worth living. Thanks for listening folks, stay warm!

New Jersey is home to 50 food desert communities, impacting approximately 1.5 million residents across all 21 counties. For these residents, daily life is marked by limited access to nutritious food, transportation challenges, economic constraints, and the resulting health risks.

But we cannot allow this to define us. I see an opportunity – a chance to transform our communities, to empower individuals, and reignite hope and purpose for every resident of our great state. By addressing these challenges through urban agriculture, we can also reduce our taxes in the State of New

Jersey. Healthier communities mean less strain on public health resources, leading to cost savings at the state level. Additionally, revitalized neighborhoods will strengthen local economies and broaden the tax base, allowing for reduced property tax rates while maintaining essential public services.

Urban agriculture isn't just about growing food; it's about growing opportunities, reducing costs, and strengthening our communities. By transforming food deserts into vibrant urban agriculture hubs, we can directly impact the cost of healthcare and property taxes for New Jersey residents. Improved access to fresh, nutritious food means healthier communities with lower rates of diet-related illnesses like diabetes, heart disease, and

obesity. This will significantly reduce the strain on our healthcare system, leading to lower healthcare costs for families and the state as a whole.

Moreover, thriving urban agriculture initiatives will stimulate local economies, increase property values, and reduce municipal expenses related to food insecurity and public health crises. SCOPE Kenya is a capacity building and networking organization that was established in 2014. SCOPE Kenya works with school communities to empower young people and transform degraded school lands into food forests through agro-ecology/permaculture practices.

It was started to strengthen and connect the ongoing initiatives of working with schools on sustainable land use and production of nutritious food.

All the members of SCOPE Kenya share a common vision of making schools across Kenya good learning examples of teacher-parent-student collaboration towards sustainable land use which would lead to significant improvements in the environment, food security, and livelihoods in the surrounding communities.

Entire school grounds are designed by the stakeholders as well as the implementation of permaculture/sustainable ecological agricultural activities. This addresses social, economic and environmental community needs. This has proved to be a very powerful and effective development tool that enhances inclusiveness, participation, ownership, and sustainability of the initiated projects in schools and at the community level.

SCOPE also takes part in capacity building activities with the school communities which enable them to transform their degraded school land into productive landscapes that have supported a diverse variety of food crops.

Capacity building occurs during workshops where the stakeholders or representatives of the school communities are thoroughly trained on the Integrated Land Use Design approach that is used to enhance participation of communities in sustainable land use, in turn supporting community development.
